For many of the nation's undocumented youth, President's Obama's Deferred Action for Childhood Arrivals program, better known as DACA, has been a buoy of hope. Although DACA doesn't provide a path to citizenship, or even legal status, the program does provide eligible youth relief from deportation and the ability to work in the United States for a renewable two-year period. DACA guidelines require beneficiaries to be enrolled in school, be a high school graduate or have served in the U.S. armed forces. The program, which was established in August 2012, is now open to renewal applications from the more than half a million DACA recipients.

DACA is administered by U.S. Citizenship and Immigration Services (USCIS) and requires applicants to file three separate forms for consideration (Forms I-821D, I-765 and I-765WS). In addition to the \$465 USCIS filing fees, immigration attorneys will generally charge several hundred dollars for preparation of the three forms. This has made the program difficult to afford for many and unattainable for others.

CitizenPath, which was founded by immigration attorneys and internet experts, uses the web to simplify otherwise complex immigration forms required by USCIS. The company's website provides applicants with step-by-step instructions and even alerts users when an answer could be problematic. CitizenPath's service facilitates the preparation of the DACA application and provides simplified filing instructions for a low cost.
